## Erasmus+: What's new for the 2021-2027 programming period?

On 25<sup>th</sup> March, 2021 the European Commission adopted the first annual work programme of Erasmus+ 2021-2027. With a budget of €26.2 billion, (compared to €14.7 billion for 2014-2020), complemented with about €2.2 billion from EU's external instruments. It will seek to be even more inclusive and to support the green and digital transitions Erasmus+ will also support the resilience of education and training systems in the face of the pandemic.

The new Erasmus+ programme (2021-2027) provides opportunities for study periods abroad, traineeships, apprenticeships, and staff exchanges in all fields of education, training, youth and sport. It is open to school pupils, higher education and vocational education and training students, adult learners, youth exchanges, youth workers and sport coaches.
